KEC net revenues up by 36.3%, Order book Jumps to ₹ 9,200 crore

- Revenue at ₹ 1,459 crore, up by 36.3% Y-o-Y
- PAT at ₹ 81 crore, up by 39.0% Y-o-Y
- Order book at ₹ 9,200 crore, up by 15.0% Y-o-Y

Mumbai, January 31, 2012: KEC International Ltd. (KEC), a billion dollar global infrastructure EPC major, an RPG Group company, today announced its unaudited consolidated results for the quarter ended December 31, 2011.

The Company's consolidated **Net Revenue** for the quarter stands at ₹ 1,459 crore as against ₹ 1,071 crore in the corresponding quarter of the previous year, registering an impressive growth of 36.3% Y-o-Y.

For the quarter, consolidated **EBITDA** is ₹ 112 crore as against ₹ 125 crore in the corresponding quarter of the previous year. Consolidated **Profit before Tax (PBT)** is ₹ 116 crore as against ₹ 85 crore in the corresponding quarter of the previous year. Profit for the current quarter includes ₹ 53 crore gains from the land sale located near Vashi.

Consolidated **Profit after Tax (PAT)** for the quarter is ₹ 81 crore as compared to ₹ 58 crore of the corresponding quarter of the previous year.

The **Order Book** continues to remain robust and currently stands at ₹ 9,200 crore. It has increased by 15.0% as compared to corresponding quarter of the previous year.

Despite the global economic slowdown, our order inflow for the quarter is approx. ₹ 2500 crore, this is the highest ever quarterly order intake for KEC.
